President's Message from Travis Dye:

It's May, which means my term as President of the WMBA is rapidly winding down. One of the goals of the WMBA is to foster camaraderie and collegiality in our profession. The primary way we try to accomplish this is by hosting monthly luncheons which give attorneys a chance to get to know their colleagues outside an office setting. Over the last several years, we have averaged around 25 attendees per luncheon. Considering there are upwards of 800 active and inactive members of the State Bar in our membership area, we, as a board, decided we could do better. To do this,

we tried to make sure we had interesting speakers and that all luncheons included CLE credit. There was also a little badgering involved! But it seems to have worked, as our attendance steadily increased from around 35 people at our first luncheon in October to nearly 70 people in March. We'll have one more chance to continue the trend with our last luncheon of this term, which is Thursday, May 19. Our speaker will be Judge Dana Christensen, the Chief Judge of the District of Montana.

For those who have attended all of our luncheons (including the one this week), you're out 90 bucks, but you have 5.75 CLE credits in your pocket and six lunches in your belly. A fair trade, if you ask me.

Unfortunately, there were many things that I was hoping to accomplish that are still in the works. We are a nine-member, volunteer board who all have busy practices and busy lives, so it takes longer to go from idea to implementation to completion. 
Pro Bono Program Update:
